FAMILY READING: HW SUPPORTS THE STATEWIDE DELIVERY OF PRIME TIME FAMILY READING, PRIME TIME PRESCHOOL, AND PRIME TIME BOXES, PROMOTING FAMILY ENGAGEMENT, PREPARING STUDENTS FOR ACADEMIC SUCCESS, CREATING FAMILY BONDS, AND CONNECTING COMMUNITIES TO THEIR LIBRARIES. IN 2024, HW SPONSORED 67 SIX-WEEK FAMILY READING PROGRAMS AT LIBRARIES, SCHOOLS, AND OTHER YOUTH-SERVING ORGANIZATIONS IN ALL CORNERS OF THE STATE, BENEFITING NEARLY 3,100 CHILDREN AND THEIR CAREGIVERS. PARTICIPANTS DEMONSTRATED IMPROVED CONFIDENCE AROUND READING, WITH 91% INCREASING THE AMOUNT OF TIME THEY READ TOGETHER, 90% EXPERIENCING POSITIVE CHANGES IN ATTITUDES TOWARD READING, AND 98% MORE LIKELY TO USE LIBRARY SERVICES.

TOPICS ARE AS DIVERSE AS THE COMMUNITIES THEY SERVE, WITH 39 SPEAKERS COVERING HISTORY, POLITICS, MUSIC, PHILOSOPHY, AND MORE. IN 2024, OVER 9,700 PEOPLE ATTENDED 335 PRESENTATIONS.
